

Sortify – Collection Sort - Privacy Policy

Sortify – Collection Sort "the App" provides Product sorting functionality based on various Product attributes as "the Service" to merchants who use Shopify to power their stores. This Privacy Policy describes how personal information is collected, used, and shared when you install or use the App in connection with your Shopify-supported store.

Personal Information the App Collects:

When you install the App, we are automatically able to access certain types of information from your Shopify account:

1. Shopify Billing API: We use this to check and process your subscriptions to our Apps as necessary.
2. Collection API: This will be used for listing the Collections and its attributes.
3. Products API: Will be used for managing the Product details and product attributes, used for sorting.
4. Orders API: Will be used to retrieve Products Sold and provide functionality of Best-seller, Revenue and other similar functions.
5. Inventory API: This is required to provide sorting functionality based on the inventory quantity, product out of stock or back in stock / re-stocking and other such functions.
6. Additional Information collected: Shopify store information and product data which is required to support Sortify – Collection Sort functions appropriately.

Additionally, we do not collect personal information from you and/or your customers. Information about you and others who may access the App on behalf of your store, such as your name, address, email address, phone number, and billing information; Information about individuals who visit your store, such as their IP address, web browser details, time zone, and information about the cookies installed on the particular device.

We may collect personal information directly from the relevant individual, through your Shopify account and we understand that Shopify has your express consent for collection of such data, or using the following Cookie technology: Use of Cookies: "Cookies" are data files that are placed on your device or computer and often include an anonymous unique identifier. "Log files" track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps. "Web beacons," "tags," and "pixels" are electronic files used to record information about how you browse the Site.

How Do We Use Your Personal Information?

We use this personal information to: communicate with you; optimize or improve the App; and provide you with information or advertising relating to our products or services.

Sharing Your Personal Information

We may also share your Personal Information to comply with applicable laws and regulations, to respond to a subpoena, search warrant or other lawful request for information we receive, or to otherwise protect our rights.

Behavioural Advertising: As described above, we use your Personal Information to provide you with targeted advertisements or marketing communications we believe may be of interest to you.
